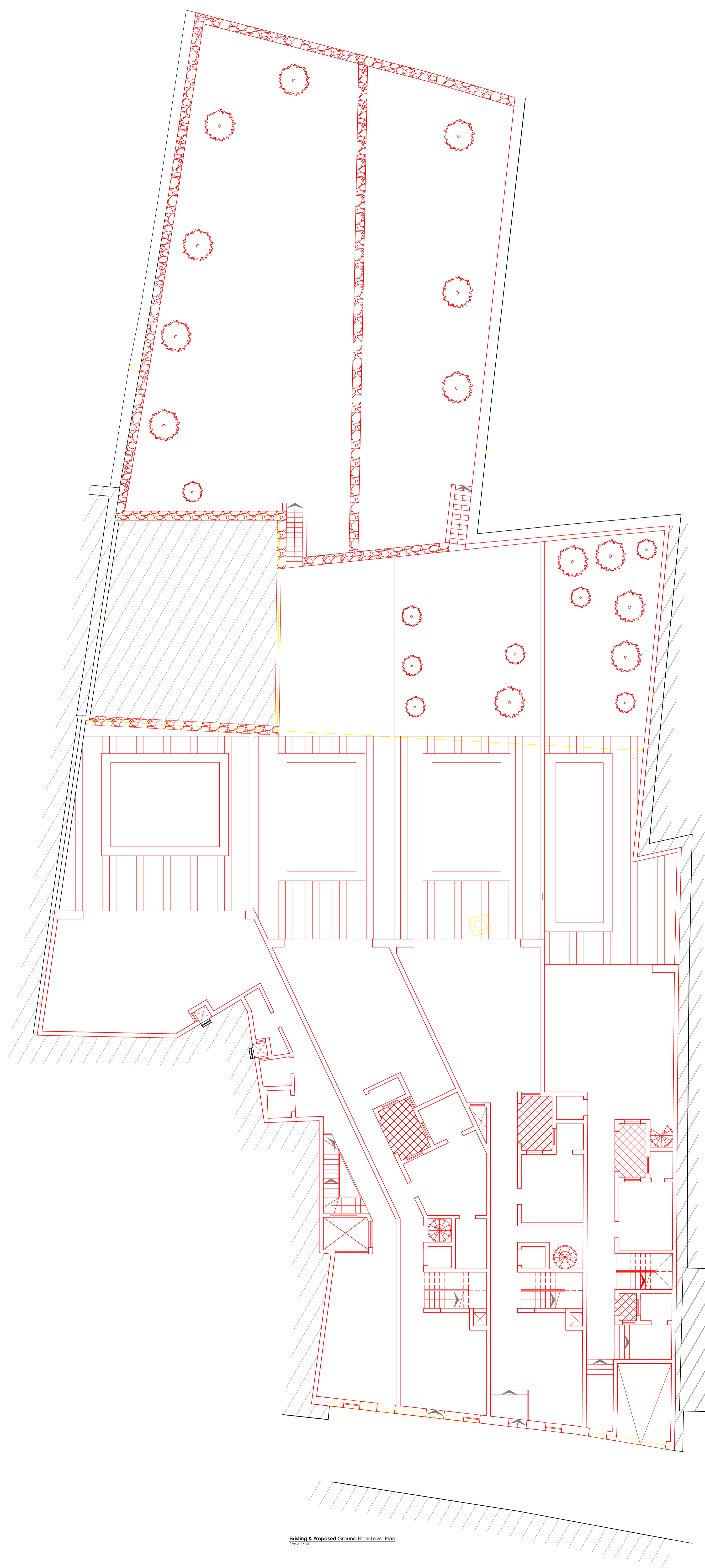




Existing Ground Floor Level Plan

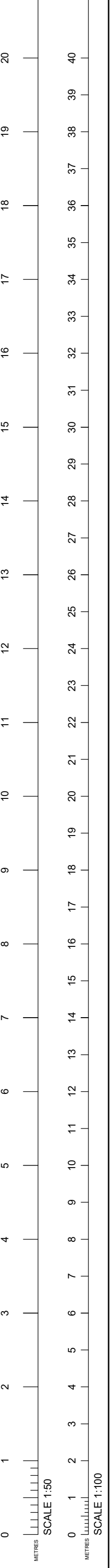
Proposed First Floor Level Plan

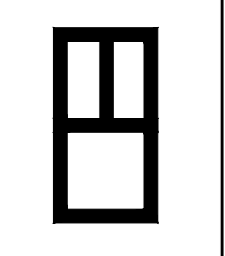
Proposed Second Floor Level Plan

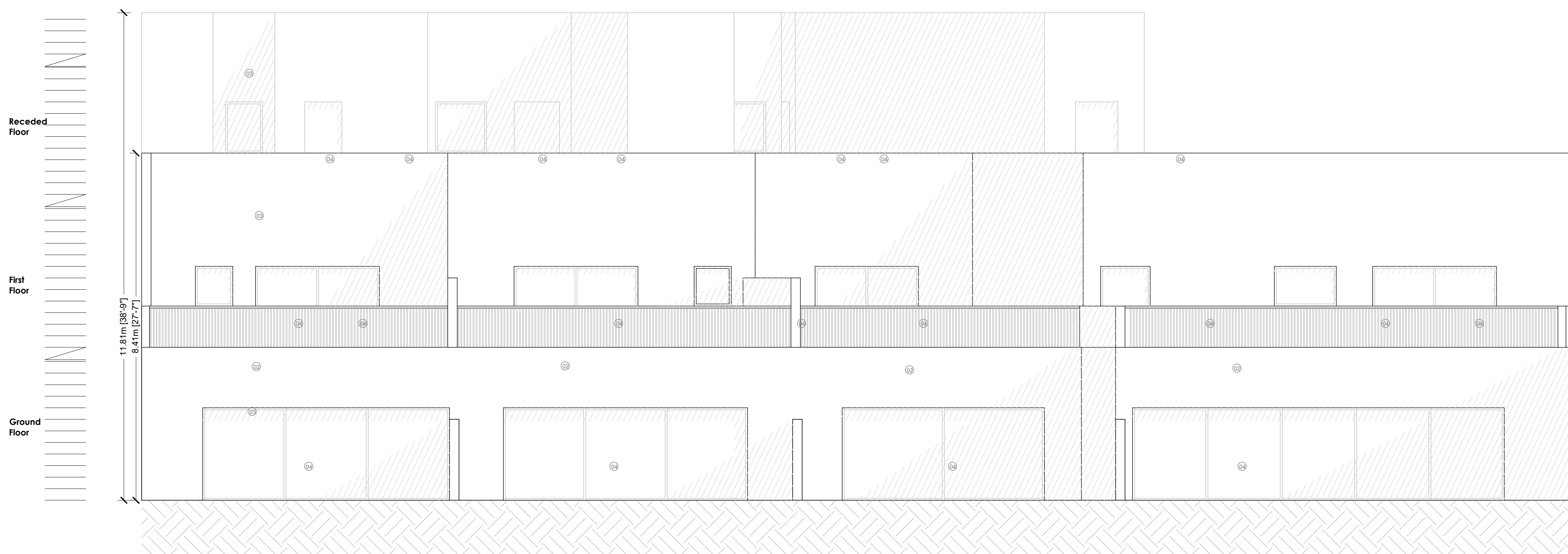
Existing Front Elevation

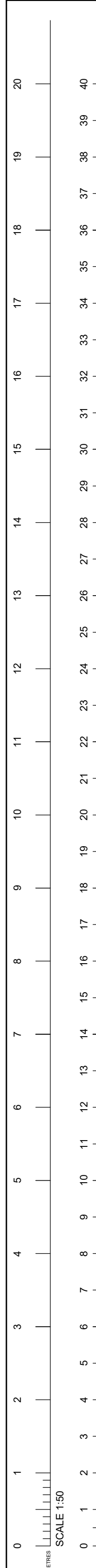
Proposed Back Elevation
